

# **Privacy Policy**

## **About this Privacy Policy**

This Privacy Policy has been published to provide a clear and concise outline of how and when personal information is collected, disclosed, used, stored and otherwise handled by Pacit Pty Ltd ACN 009 282 704 trading as Leasing Services of Western Australia ('Leasing Services').

The Policy relates to personal information collected by any means, by any technology and assumes that you are an Australian resident.

By using Leasing Services' website, products or services, you consent to Leasing Services obtaining and using your personal information as set out in this Privacy Policy.

Leasing Services treats the handling of your personal information very seriously. To that end, it has systems and procedures in place to protect your privacy in relation to the handling of your personal information.

Leasing Services' objective is to handle your personal information responsibly and provide you with some control over the way information about you is handled and stored.

## Our Commitment to Protect Your Privacy.

We recognise that any personal information we collect about you will only be used for the purposes we have collected it or as allowed under the law. It is important to us that you are confident that any information we hold about you will be treated in a way which ensures protection of that information.

Our commitment in respect of your information is to abide by the Australian Privacy Principles, as set out in the Privacy Act 1988 (Cth) and other relevant law.

## **Personal Information.**

When we refer to personal information we mean information from which your identity is reasonably apparent or could reasonably be concluded. This information may include information or an opinion about you.

The personal information we hold about you will also include credit information.

Credit information is information which is used to assess your eligibility to be provided with finance and may include any finance that you have outstanding, your repayment history in respect of those loans, and any defaults. Usually, credit information is exchanged between credit and finance providers and credit reporting bodies.

The kinds of personal information we collect about you includes your name, date of birth, address, occupation, and any other information we made need to identify you.

If you are applying for finance, we may also collect the ages and number of your dependants and cohabitants, the length of time at your current address, your employment and credit history and proof of earnings and expenses. In order to assist you we may be required to collect other information relevant to your application for credit in accordance with the Lender's Credit Policy.

## Why We Collect Your Personal Information.

We collect personal information for the purposes of assessing your application for finance and managing that finance. We are also required to collect personal information to comply with our requirements in relation to our lenders agreements which includes the lenders anti money laundering and counter terrorism financing obligations. We may also collect your personal information for the purposes of direct marketing and managing our relationship with you. From time to time we may offer you other products and services.

To enable us to maintain a business relationship with you, we will disclose your personal information to other organisations that provide products or services used by us.

## How Do We Collect Your Personal Information?

Where reasonable and practical we will collect your personal information directly from you. For your convenience, we may also collect some of your personal information from other financial institutions, your employer, accountant, realestate agent lawyer or referrer.

## Website

As well as collecting information such as contact and address details, our website also records traffic statistics such as the number of visitors to our site, the date and the time of the visits, the numbers of pages viewed, etc. These details are primarily used for optimising our site and its performance. Any details recorded are anonymous and we cannot link your identity to these statistics.

## Do We Disclose Your Personal Information?

We may disclose your personal information:

• to prospective financiers or other institutions or intermediaries in relation to your finance or mortgage requirements;

• to companies who provide company and director search information;

• to other organisations that are involved in managing or administering your finance such as third party suppliers, printing and postal services;

• to companies that provide infrastructure systems to us;

• to anybody who represents you, such as financial institutions, real estate agents, lawyers and accountants;

• to anyone including guarantors, where you have provided us consent;

• where we are required to do so by law, such as our obligations under our lenders agreements to comply with their Anti-Money or Laundering and Counter Terrorism Financing Act 2006 (Cth) obligations; or

• to your employer, referees or identity verification services.

Prior to disclosing any of your personal information to another person or organisation, we will take all reasonable steps to satisfy ourselves that:

a) the person or organisation has a commitment to protecting your personal information at least equal to our commitment, or

b) you have consented to us making the disclosure.

We may use cloud storage to store the personal information we hold about you. The cloud storage and the IT servers may be located outside Australia. We may disclose your personal information to overseas entities that provide support functions to us. You may obtain more information about these entities by contacting us.

## **Direct Marketing**

From time to time we may use your personal information to provide you with current information about finance, offers you may find of interest, changes to our organisation, or new products or services being offered by us.

If you do not wish to receive marketing information, you may at any time decline to receive such information by emailing us at harry@leasingservices.com.au. If the direct marketing is by email you may also use the unsubscribe function. We will not charge you for giving effect to your request and will take all reasonable steps to meet your request at the earliest possible opportunity.

## Updating Your Personal Information.

It is important to us that the personal information we hold about you is accurate and up to date. During the course of our relationship with you we may ask you to inform us if any of your person al information has changed.

We will generally rely on you to ensure the information we hold about you is accurate or complete. If you wish to make any changes to your personal information, please contact us.

## Access and Correction to Your Personal Information.

We will provide you with access to the personal information we hold about you. You may request access to any of the personal information we hold about you at any time. We may charge a fee for our costs of retrieving and supplying the information to you, depending on its location and volume. Depending on the type of request that you make we will usually respond to you within 14 days of receiving your request. We may need to contact other entities to properly investigate your request. There may be situations where we are not required to provide you with access to your personal information, for example, if the information relates to existing or anticipated legal proceedings, or if your request is vexatious. An explanation will be provided to you if we deny you access to the personal information we hold about you.

If any of the personal information we hold about you is incorrect, inaccurate or out of date you may request that we correct the information. If appropriate we will correct the information at the time of the request. Otherwise, we will provide an initial response to you within 7 days of receiving your request.

Where reasonable, and after our investigation, we will provide you with details about whether we have corrected the personal information within 30 days. If we refuse to correct personal information we will provide you with our reasons.

## Using Government Identifiers.

If we collect government identifiers, such as your tax file number, we do not use or disclose this information other than required by law. We will never use a government identifier in order to identify you.

## Business Without Identifying You.

In most circumstances it will be necessary for us to identify you in order to successfully do business with you. However, where it is lawful and practicable to do so, we will offer you the opportunity of doing business with us without providing us with personal information, for example, if you make general inquiries about interest rates.

## Sensitive Information.

Sensitive information is personal information that includes information relating to your racial or ethnic origin, political persuasion, memberships in trade or professional associations or trade unions, sexual preferences, criminal record, or health. At this time we do not collect any sensitive information.

## How Safe and Secure is Your Personal Information that We Hold?

We will take reasonable steps to protect your personal information by storing it in a secure environment. We may store your personal information in paper and / or electronic form. We will also take reasonable steps to protect any personal information from misuse, loss and unauthorised access, modification or disclosure.

## Complaints

If you are dissatisfied with how we have dealt with your personal information, or you have a complaint about
